

**Record of Proceedings
Coshocton City Council
Meeting Held: February 26, 2018**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Mr. Cliff Biggers. Council Members present were Mr. Mike Gross, Mr. Chad Johnson, Ms. Jackie Salmans, Mr. Brad Fuller, Mr. Roger Moore, Mr. Glenn Mishler and Tom Grier. Also, present Mr. Steve Mercer, Mayor; Mr. Max Crown, Safety Service Director and Ms. Cherry Wilson, Clerk.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 2/12/18. Tom Grier made the motion to accept the minutes as presented, seconded by Mike Gross. After roll call vote all members voted yes.

Petitions & Remonstrance's: None

Reports of Standing or Special Committees: Brad Fuller announced the Ordinance Committee would hold a public meeting to discuss the "Noise Ordinance" and receive public comments at 6pm on Monday, March 5th.

Roger Moore said he was disappointed the ordinance was tabled and had taken this long. He felt concerned that council was sitting a bad precedent for future ordinances. He would like to see it back on the agenda and voted on as soon as possible.

Mike Gross said he wanted to go on record that he agrees with Roger Moore and that he is disappointed in the way this has been delayed.

Brad Fuller addressed their concerns saying he doesn't feel the time change will solve the problem, he wants to address volume and other issues.

City Officers Report:

Mayor's Report: Mayor Mercer clarified that the Ordinance Committee is asking for the special meeting and it will be held in Council Chambers.

Service Director's Report: Max Crown said we have a lot of potholes and are patching with cold mix, still not able to get hot mix yet.

Sheriff's Office Report: Sheriff Rogers reported three people are in custody from a drug raid done in the Locust and Third Street area last week. He also said the body scanner is up and running, they are using it 24/7. Everyone who is arrested off the street is scanned and anyone that leaves the facility is scanned on return.

Law Director's Report: Bob Skelton was present his report was included in council packets.

Port Authority Director's Report: Absent, the director's monthly report was included in council packets along with a copy of the annual CRA (Community Reinvestment Area).

Introduction of Ordinances:

Legislation at first reading:

9-18 an ordinance establishing the 2018 pay schedule for the Recreation Department and Seasonal Workers. Ordinance to take its course.

10-18 an ordinance to amend Chapter 1311 Section 1311.04 of the City of Coshocton's Codified Ordinances. After the first reading Jackie Salmans made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Tom Grier made a motion to suspend the rules and give the ordinance a third

reading, seconded by Mike Gross, all members voted yes. After the third reading all members voted yes. Ordinance 10-18 was passed with emergency clause.

Legislation at second reading:

7-18 an ordinance approving the addition and inclusion of certain ordinances as part of the various component codes of the Codified Ordinances of the City of Coshocton by the Walter Drane Company. Ordinance to take its course.

Legislation at third reading:

4-18 an ordinance authorizing the mayor or service director to prepare specifications, advertise and let a bid for Chlorine, Fluoride, Alum, Lime, CO2, Sodium Hexametaphosphate and Gasoline. After the third reading all members voted yes. Ordinance 4-18 passed.

6-18 an ordinance to amend the zoning map of the City of Coshocton for 1991 Otsego avenue. After the third reading all members voted yes. Ordinance 6-18 passed.


Unfinished Business: None
