

**Record of Proceedings
Coshocton City Council
Meeting Held: May 22, 2017**

6:45 Hearing for PC -17/Ordinance 17-17 to rezone 1502 Chestnut Street from R-2 One & Two Family Residence District to a B-1 Neighborhood Business District. All fees have been paid and there was no correspondence regarding the application. Mr. Thompson was present and explained his request to council. He and his wife intend to run their construction company and real estate business from this location.

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers, Council Members present were Mr. Bob Fetters, Mr. Chad Johnson, Ms. Jackie Salmans, Mr. Brad Fuller, Mr. Roger Moore, Mr. Tom Grier and Mr. Glenn Mishler. Also present Mr. Steve Mercer, Mayor; Mr. Jerry Stenner, Safety Service Director and Ms. Cherry Wilson, Clerk.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 5/8/17. Tom Grier made the motion to accept the minutes as presented seconded by Chad Johnson. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Tina Dobson asked council again about getting water on Hillsdale Drive. Councilman Moore informed her they have had meetings and are still in the process of prioritizing where to start with the water expansion.

Reports of Standing or Special Committees: None

City Officers Report:

Mayor's Report: Mayor Mercer asked council to confirm his appointment of Justin Thompson to the Coshocton County Regional Planning Commission. All members voted yes.

Mayor Mercer presented Jerry Stenner with a proclamation for his years of service as the Safety Service Director. Mr. Stenner is retiring at the end of May.

The Mayor went over what had been discussed in the committee meeting regarding the city's choice on allowing medical marijuana cultivation to operate within the city limits. The Mayor informed council that a company is interested in building in Coshocton so they need to think about how they want to proceed with this decision.

Council President told council to be cautious and very careful with their decision.

Service Director's Report: Jerry Stenner thanked everyone for their well wishes. He expressed that it had been a joy working with everyone on council, the Department Heads and all the employees. He welcomed Max Crown saying the Mayor made a wonderful decision appointing Max to the position; he will do an excellent job.

Law Director's Report: Bob Skelton was present his April Report was included in council packets.

Sheriff's Report: Sheriff Rogers was present with no report. Chad Johnson asked the Sheriff if it was legal for a truck to drive around with no doors on it. The Sheriff said he will check Ohio Revised Code on that.

Fire Chief's Report: Chief Layton was present with no report; he wished Jerry Stenner the best on his retirement.

Auditors Report: Auditor Sherry Kirkpatrick also wished Jerry the best on his retirement; she will miss seeing him at City Hall. Sherry asked that the Detailed Check Report dated 5/3/17 and the Then and Now's dated 5/3/17 be approved tonight. Jackie Salmans made a motion to approve the Auditor's reports, seconded by Glenn Mishler, all members voted yes.

Ordinance 18-17 passed with emergency clause.


