29-19 an ordinance amending Chapter 1311.19 parking trucks in commercial and residential districts of the City of Coshocton's Codified Ordinances. 31-19 an ordinance authorizing the Mayor or Service Director to sign all documents necessary for the city to purchase property at 237 South Seventh Street in the City of Coshocton. After the first reading Jackie Salmans made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Mike Gross, all members voted yes. After the third reading all members voted yes. Ordinance 31-19 passed with the emergency clause.

32-19 an ordinance adding Section 1113.99 penalties of the City of Coshocton's Codified Ordinances. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Jackie Salmans, all members voted yes. After the second reading Jackie Salmans made a motion to suspend the rules and give the ordinance a third reading, seconded by Chad Johnson, all members voted yes. After the third reading all members voted yes. Ordinance 32-19 passed with the emergency clause.
