

**Record of Proceedings
Coshocton City Council
Meeting Held: May 8, 2017**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers, Council Members present were Mr. Bob Feters, Mr. Chad Johnson, Ms. Jackie Salmans, Mr. Brad Fuller, Mr. Roger Moore, Mr. Tom Grier and Mr. Glenn Mishler. Also present Mr. Steve Mercer, Mayor; Mr. Jerry Stenner, Safety Service Director and Ms. Cherry Wilson, Clerk.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 4/24/17. Tom Grier made the motion to accept the minutes as presented seconded by Glenn Mishler. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Tim Holdsworth of Stewart Lane informed council of his concern for the students trying to get to Kids America. He feels Kids America is one of the greatest things in Coshocton and gave some alternatives that he felt the city could do to make it safer for bike and foot travelers to get there. Mr. Holdsworth had done some research for the city and gave them information on what he had gathered. Mayor Mercer thanked him for his thorough presentation and assured him the city has already been looking at that area.

City Officers Report:

Mayor's Report: Mayor Mercer presented Colton Conkle with a Proclamation in honor of his being the 2017 State Champion for the Elks National Hoop Shoot Competition for the boys age division 8-9. He presented Conkle with the proclamation, a city flag pin and a key to the city. Conkle shot 25 out of 25 to become the champion. The Mayor also went over his April Report that was included in council packets.

Service Director's Report: Jerry Stenner congratulated Colton on his accomplishment said it was quite a feat you have pulled off. Stenner said the Public Works is out patching potholes.

Law Director's Report: Bob Skelton was present with no report

Sheriff's Report: Sheriff Rogers was present and said the new canine is here and will start school at the end of this month. He said the donations for the school far exceeded what was needed and the Veterinary Association has been very kind also. He announced the Sheriff's Office is purchasing a body scanner to keep drugs and other contraband from getting into the jail. They may have to build a small addition to fit the scanner.

Fire Chief's Report: Chief Layton was present with no report

Auditors Report: Auditor Sherry Kirkpatrick was present and asked that the Detailed Check Report dated 4/19/17; Then and Now's dated 4/19/17 and the Cash Statement dated 4/28/17 be approved tonight. Jackie Salmans made a motion to approve the Auditor's report, seconded by Roger Moore, all members voted yes.


Unfinished Business: None
