**Petitions & Remonstrance's:** Greg Darr with Coshocton Metropolitan Housing asked council for a resolution supporting a grant they are applying for to become a Residential Advisory Development group, they are losing HUD funding. The grant will pay for legal documentation to change from HUD to RAD. President Biggers disclosed he is the President of Coshocton Metropolitan Housing Board.

Mike Jensen attended again to ask council to repel the Resolution regarding medical marijuana manufacturing and to ask council to ban dispensaries and recreational use in Coshocton.

Tina Dobson of Hillsdale Drive came to request water on Hillsdale Drive she was wearing a sign asking "got water?" and carrying several empty water jugs. She said they are in desperate need for water and she has to keep drawing attention to their need.
