

**Record of Proceedings
Coshocton City Council
Meeting Held: July 24, 2017**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers, Council Members present were Mr. Bob Feters, Ms. Jackie Salmans, Mr. Roger Moore, Mr. Tom Grier and Mr. Glenn Mishler. Jackie Salmans made a motion to excuse Mr. Brad Fuller, seconded by Tom Grier, all members voted yes. Also present Mr. Steve Mercer, Mayor; Mr. Max Crown, Safety Service Director and Ms. Cherry Wilson, Clerk.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 7/10/17. Tom Grier made the motion to accept the minutes as presented seconded by Glen Mishler. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Mike Jensen attended again to ask council to rescind the Resolution regarding medical marijuana manufacturing and to ask council to ban dispensaries and recreational use in Coshocton.

Sheriff's Report: Sheriff Rogers said his office is working with the FBI on the City Hall bomb/anthrax threat and should have more information in the near future. 
Unfinished Business: None
