

**Record of Proceedings
Coshocton City Council
Meeting Held: October 10, 2017**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers, Council Members present were Mr. Bob Fethers, Mr. Brad Fuller, Mr. Tom Grier, Mr. Chad Johnson, Mr. Glenn Mishler, Mr. Roger Moore and Ms. Jackie Salmans. Also present Mr. Steve Mercer, Mayor; Mr. Max Crown, Safety Service Director and Ms. Cherry Wilson, Clerk.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 9/25/17. Chad Johnson made the motion to accept the minutes with a correction adding him to members present, seconded by Tom Grier. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Mike Jensen and Terri Baker both spoke opposing the resolution welcoming medical marijuana cultivation.

Reports of Standing or Special Committees: None

City Officers Report:

Mayor's Report: Mayor Mercer went over his September Report that was included in council packets. The Mayor reported Coshocton received a four bloom award from America in Bloom and a special honor award for outstanding floral displays for the baskets all around town. He gave an update on the medical marijuana applications. "Council has expressed interest in not allowing dispensaries but there is no interest to rescind the manufacturing resolution. The moratorium will remain in effect until November 30, 2017 and all applications for dispensaries were due on November 1st – 17th". Mayor Mercer also said the city wants to become a regional water supplier throughout the county. We have a wonderful infrastructure of water and sewer.

President Biggers went on record saying he is opposed to the medical marijuana resolution. I suggest council talk to people that deal with addiction or deal with addicts. He feels marijuana is a gateway drug to addiction. As a policeman and clergy, I have seen the devastation of drugs and how it effects people from all walks of life. I do not have a vote but I do have a voice.

Service Director's Report: Max Crown reported on additional pavement projects that will be done this season, Overlook Drive, Woodcrest Lane, Ridgewood Drive, Denman from Cambridge Road to Railroad tracks, part of Sleepy Hollow, Mulberry Street by the football field.

Law Director's Report: Bob Skelton was present with no report.

Tax Administrator's Report: Absent, September report was included in council packets.

Auditors Report: Auditor Sherry Kirkpatrick was present and asked council to approve the Then and Now's dated 9/20/17, Detailed Check Report dated 9/20/17 and Cash Statement dated 9/29/17. Jackie Salmans made a motion to accept the reports, seconded by Chad Johnson all members voted yes.

Property Code Investigator's Report: Jon Cotterman was present and passed out his report to council.

Introduction of Ordinances:

Legislation at first

33-17 Appropriations. After the first reading, Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Glenn Mishler made a motion to give the ordinance a third reading, seconded by Tom Grier, all members voted yes. After the third reading all members voted yes. Ordinance 33-17 passed with the emergency clause.

34-17 Transfers. After the first reading, Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Bob Fethers, all members voted yes. After the second reading Brad Fuller made a motion to give the ordinance a third reading, seconded by

Chad Johnson, all members voted yes. After the third reading all members voted yes. Ordinance 34-17 passed with the emergency clause.

Legislation at second reading:
None

Legislation at third reading:
28-17 an ordinance to amend zoning ordinances in the City of Coshocton's Codified Ordinances. After the third reading all members voted yes. Ordinance 28-17 passed.

Resolutions: 12-17 a resolution to grandfather properties along the East and West sides of Burt Avenue from Orange to 8th Streets that have been built on the City's property, originally platted in 1867. Roll call vote all members voted yes. Resolution 12-17 was adopted.


Unfinished Business: None
