

**Record of Proceedings  
Coshocton City Council  
Meeting Held: December 18, 2017**

The regular session of the Coshocton City Council was called to order at 5:00 pm by Council President Cliff Biggers, Council Members present were Mr. Bob Fetters, Mr. Brad Fuller, Mr. Chad Johnson, Mr. Glenn Mishler, Mr. Roger Moore and Ms. Jackie Salmans. Chad Johnson made a motion to excuse Tom Grier, seconded by Bob Fetters, all members voted yes. Also, present Mr. Steve Mercer, Mayor; Mr. Max Crown, Safety Service Director and Ms. Cherry Wilson, Clerk.

**Previous Meeting Minutes:** President Biggers confirmed that all council members had received the minutes from 12/11/17. Chad Johnson made the motion to accept the minutes as presented, seconded by Glenn Mishler. After a roll call vote all members voted yes.

**City Officers Report:**

Mayor's Report: Mayor Mercer and President Biggers acknowledged Bob Fetters service with a Certificate of Appreciation signed by all council members. Mr. Fetters, Mrs. Fetter and council posed for several pictures after.

Service Director's Report: Max Crown reported leaf pick up finished this week will make one more round to pick up extra. Max thanked Bob Fetters for his service and help he gave him when he first started and Mr. Fetter's help with the North End Revitalization Project. Max wished everyone a Merry Christmas.

Law Director's Report: Bob Skelton was present, and his November Report was included in council packets. He thanked Mr. Fetters for his service.

Sheriff's Office Report: Sheriff Rogers was present and also thanked Mr. Fetters for his service. He said a pursuit started in Coshocton County and ended in another county. Heneta was an important part of the apprehension.

Auditors Report: Auditor Sherry Kirkpatrick was present and asked council to approve the Then and Now's dated 12/13/17 and Detailed Check Report dated 12/13/17. Brad Fuller made a motion to accept the reports as presented, seconded by Roger Moore all members voted yes. Sherry told Bob Fetters it was a pleasure to work with you, you always came in and asked questions. She spoke about the length of time she and Bob served on council together.

**Introduction of Ordinances:**

Glenn Mishler made a motion to add Ordinance 57-17 to the Agenda, seconded by Jackie Salmans, all members voted yes.

**Legislation at first**

56-17 transfers. After the first reading Jackie Salmans made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Brad Fuller, all members voted yes. After the third reading all members voted yes. Ordinance 56-17 passed.

57-17 an ordinance authorizing the Mayor or Service Director to sign all documents necessary for the City to purchase property at 135 Bridge Street in the City of Coshocton. After the first reading Jackie Salmans made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Glenn Mishler made a motion to suspend the rules and give the ordinance a third reading, seconded by Bob Fetters, all members voted yes. After the third reading all members voted yes. Ordinance 57-17 passed.

**Legislation at second reading:**

52-17 an ordinance authorizing all actions necessary to affect an Opt-out Electric Service Aggregation Program pursuant to section 4928.20, Ohio Revised Code, directing the County Board of Elections to submit a ballot question to the electors. Ordinance to take its course.

53-17 an ordinance authorizing all actions necessary to effect an Opt-out Natural Gas Aggregation Program pursuant to section 4929.26, Ohio Revised Code, directing the County Board of Elections to submit a ballot question to the electors. Ordinance to take its course.

54-17 an ordinance to amend section 509.03 Unreasonable Noise; Amplifications Devices of the City of Coshocton's Codified Ordinances. Ordinance to take its course.

**Legislation at third reading:**

38-17 an ordinance to appropriate funds for current expenses and other expenditures for the City of Coshocton, State of Ohio, for January 1, 2018, through December 31, 2018. After the third reading all members voted yes. Ordinance 38-17 passed.

43-17 an ordinance establishing wages for Treasurer. After the third reading all members voted yes. Ordinance 43-17 passed.

47-17 an ordinance establishing wages for Council Members, President of Council and Clerk of Council for calendar years 2018 and 2019. After the third reading all members voted yes. Ordinance 47-17 passed.

48-17 an ordinance amending ordinance 10-16 changing wages for the Safety Coordinator. After the third reading all members voted yes. Ordinance 48-17 passed.

51-17 an ordinance to amend the zoning map of the City of Coshocton for 1909 and 1911 Chestnut Street. After the third reading all members voted yes. Ordinance 51-17 passed.


**Unfinished Business:** None
