The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers. Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 1/28/19. Glenn Mishler made the motion to accept the minutes as presented, seconded by Chad Johnson. After a roll call vote all members voted yes.

City Officers Reports:

Mayor's Report: Mayor Mercer reported there is a tentative agreement with the Sheriff on the contract with the City and the Sheriff's Office, council will be presented with an ordinance in two weeks to accept the contract. He also just learned that the AFSCME union voted to accept the contract and accepted the fact finders report. The Mayor's monthly reports were emailed to council on 2/1/19.

After the second reading Tom Grier made a motion to suspend the rules and give the ordinance a third reading, seconded by Chad Johnson, all members voted yes. After the third reading all members voted yes. Ordinance 9-19 passed with emergency clause.

10-19 an ordinance amending chapter 979.03 of the City of Coshocton's Codified Ordinances container and placement requirements. Ordinance to take its course.

11-19 an ordinance approving the fact finding report between the City of Coshocton and AFSCME Local #2551 and approving the funds necessary to implement agreement and authorizing the mayor or service director to sign the contract with AFSCME Local #2551. After the first reading Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Glenn Mishler, all members voted yes. After the second reading Brad Fuller made a motion to suspend the rules and give the ordinance a third reading, seconded by Chad Johnson, all members voted yes. After the third reading all members voted yes. Ordinance 11-19 passed.
