Record of Proceedings Coshocton City Council Meeting Held: March 27, 2017

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 3/13/17. Glenn Mishler made the motion to accept the minutes as presented seconded by Tom Grier. After a roll call vote all members voted yes.

Petitions & Remonstrance's: None

Reports of Standing or Special Committees: Glenn Mishler reported the Infrastructure Committee met briefly last Monday, they are exploring options for moving forward on expanding the city water lines.

City Officers Report:

<u>Mayor's Report:</u> Mayor Mercer reported he had attended the monthly Health Board meeting this evening and the accreditation process is proceeding well. They have met with several focus groups and that has worked well. They project making the official application in 2018 and that falls within the perimeter of the requirements.

Service Director's Report: Jerry Stenner was present with no report.

<u>Law Director's Report:</u> Bob Skelton was present and his report was included in council packets. He has received no input from the Board of Elections on the resolution regarding council terms so he will bring it to council next Monday for approval.

<u>Sheriff's Office Report:</u> Sheriff Rogers was present and shared details about a second canine officer they are looking to add. Councilman Bob Fetters asked the Sheriff about vans riding around town with their sliding side doors open, Sheriff Rogers said he will check the law on that.

<u>Auditors Report:</u> Auditor Sherry Kirkpatrick was absent but had previously passed out copies of the Detailed Check Report dated 3/10/17 and asked for it to be approved tonight. Brad Fuller made a motion to approve the Auditor's report, seconded by Roger Moore, all members voted yes.

Fire Department: Chief Layton was present with no report.
