

**Record of Proceedings
Coshocton City Council
Meeting Held: April 23, 2018**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Pro Tem Ms. Jackie Salmans. Council Members present were Mr. Mike Gross, Mr. Chad Johnson, Ms. Jackie Salmans, Mr. Brad Fuller, Mr. Roger Moore, Mr. Glenn Mishler, Mr. Tom Grier and Cherry Wilson, Clerk. President Cliff Biggers was absent and had notified the clerk of his absence. Also, present Mr. Steve Mercer, Mayor and Mr. Max Crown, Safety Service Director.

Previous Meeting Minutes: President Pro Tem Salmans confirmed that all council members had received the minutes from 4/9/18. Chad Johnson made the motion to accept the minutes as presented, seconded by Tom Grier. After roll call vote all members voted yes.

Petitions & Remonstrance's: Richard Emler of Park Avenue expressed his concerns regarding a rumor that a fracking company wants to put contaminated water in Coshocton. He also mentioned the graffiti on the back of the Sprint Print Building on Main Street. Glenn Mishler addressed the fracking concern saying Buckeye Brine (not in the city limits) has applied to change their well type. Tom Grier clarified they are currently injecting Brine Water which is a waste product from fracking wells, they are not fracking.

Barbara ~~Teddy~~ with the Coshocton Environment Awareness group expressed her concerns with Buckeye Brine changing their well type to be able to accept and inject hazardous material. She could find no documentation where any company in the United States has converted from a class one well to a class two. There will be required public meeting for this application process.

Todd Shroyer from Coshocton County Emergency Medical Service was present to explain the need for the levy that will be on the May ballot. The agency is at minimum staff now with 4 crews if levy does not pass they will have to cut another crew and it could affect their response times. Currently 80% of their calls, responders are at the door in less than 8 minutes.

Devin Albert and Cindy Hemming approached council about adding 2 "Take a Book, Leave a Book" Libraries in the City. One will be at the Art Park on Main Street. He was there to ask the City's guidance on where to place the second one and if the city would help with installation. City Hall was proposed as the second location.

Anne Cornell with the Pomerene Center thanked council for their financial support.

Reports of Standing or Special Committees: Brad Fuller reported the vacant property ordinance will be ready for council at the next committee meeting on May 7th.

City Officers Reports:

Mayor's Report: Mayor Mercer spoke about ordinance 29-18 and the upcoming vacant property ordinance.

Service Director's Report: Max Crown reported another successful Coshocton City Clean-up Day. The weather was great, there were approximately 125-150 volunteers that picked up approximately 4 tons of trash. Max thanked everyone for participating.

Sheriff's Office Report: An officer was present and reported the Sheriff's Office is doing well.

Law Director's Report: Bob Skelton was present; his monthly report was included in council packets.

Auditors Report: Auditor Sherry Kirkpatrick was present and asked council to approve the Cash Statement dated 3/30/18; Detailed Check Report dated 3/21/18 & 3/27/18 and Then and Now's dated 3/21/18. Chad Johnson made a motion to accept the reports as presented, seconded by Glenn Mishler all members voted yes.

Fire Chief's Report: Chief Layton was present with no report.

Introduction of Ordinances:

Tom Grier made a motion to add Ordinance 29-18 to the Agenda, seconded by Chad Johnson, all members voted yes.

Legislation at first reading:

28-18 an ordinance vacating a 15 Foot alley totaling 0.1178 Acres from Elm Street to the end that was previously vacated by ordinance 71-46. Ordinance to take its course.

29-18 an ordinance authorizing the Mayor to sign all documents necessary for the first amendment to Job Creation Grant Agreement with Kraft Heinz Foods Company. After the first reading Roger Moore made a motion to suspend the rules and give the ordinance a second reading, seconded by Mike Gross, all members voted yes. After the second reading Brad Fuller made a motion to suspend the rules and give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 29-18 passed with the emergency clause.

Legislation at second reading:

19-18 an ordinance authorizing the Mayor or Service Director to sign all documents necessary for the city to purchase four lots at the end of North Third Street in the City of Coshocton. Ordinance to take its course.




New Business: None
