

**Record of Proceedings  
Coshocton City Council  
Meeting Held: April 24, 2017**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers, Council Members present were Mr. Bob Fетters, Mr. Chad Johnson, Ms. Jackie Salmans, Mr. Brad Fuller, Mr. Tom Grier and Mr. Glenn Mishler. Tom Grier made a motion to excuse Mr. Roger Moore, seconded by Glenn Mishler, all members voted yes. Also present Mr. Steve Mercer, Mayor; Mr. Jerry Stenner, Safety Service Director and Ms. Cherry Wilson, Clerk.

**Previous Meeting Minutes:** President Biggers confirmed that all council members had received the minutes from 4/10/17. Glenn Mishler made the motion to accept the minutes as presented seconded by Jackie Salmans. After a roll call vote all members voted yes.

**Petitions & Remonstrance's:** Brent medley of Chestnut Street requested a Proclamation be done for Colton Conkle for his National Title for the Elks Hoop Shoot. One will be presented at the next council meeting.

**Reports of Standing or Special Committees:** Glenn Mishler announced the Infrastructure Committee had met last week after the regular committee meeting to discuss a new opportunity for the public sector to work with the private sector on a project on CR 10. He also announced at the committee meeting he had passed out to council members a draft of potential assignments for each committee to be reviewed and discussed at the next committee meeting.

Service Director's Report: Jerry Stenner congratulated Colton on his winning. He said the Public Works Department will be out soon hot patching potholes the asphalt plants will be opening soon. 
**Unfinished Business:** None


