Record of Proceedings Coshocton City Council Meeting Held: April 8, 2019

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Pro Tem Jackie Salmans. Council Members present Mr. Tom Grier, Mr. Mike Gross, Mr. Chad Johnson, Mr. Glenn Mishler, Mr. Roger Moore and Cherry Wilson, Clerk. Also, present Mr. Steve Mercer, Mayor and Max Crown, Safety Service Director. Glenn Mishler made a motion to excuse Mr. Brad Fuller and President Cliff Biggers seconded by Roger Moore, all members voted yes.

Previous Meeting Minutes: President Pro Tem Salmans confirmed that all council members had received the minutes from 3/25/19. Chad Johnson made the motion to accept the minutes as presented, seconded by Tom Grier. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Several neighbors of 610 South Lawn Avenue addressed council with their concerns from Doug Gilbert's property. The property is unkept and everyone has seen an increase in mice in the neighborhood. Mayor Mercer addressed the citizens assuring them we are working on resolving the issues. Max Crown has asked for a quote to demolish all three properties Mr. Gilbert owns. Bob Skelton has citied him numerous times. It is a slow process and we will keep working on it until problem is resolved. Sheriff Rogers also said he has known Mr. Gilbert for 30 years and his office deals with him or complaints against him 1-3 times a week.

Several asked for a Slow Children at Play sign be placed in alley where the drive thru has routed traffic through the alley.

Richard Gates 821 South Lawn has concerns about the speed people are driving in his neighborhood and several do not stop at stop signs. He also has issues with loud music in his neighborhood and people driving by with loud music.

City Officers Reports:

<u>Mayor's Report:</u> Mayor Mercer thanked everyone who made an effort to come to council and speak. He went over his March Reports that were emailed to council on April 4th.

<u>Service Director's Report:</u> Max Crown reported the WWTP has received a letter from Ohio EPA and are in compliance with Mercury levels. This is an issue the city has worked on for 5 years.

Law Director's Report: Bob Skelton was present with no report.

<u>Sheriff's Report</u>: Sheriff Rogers was present and said he will do a target enforcement in the neighborhood of the speeding and not stopping at stop signs. Sheriff Rogers invited Mr. Gates to come by the Sheriff's Office to discuss the noise ordinance, you should not have to put up with that.

The Sheriff's Office has done several indictments and has several more to go. There was a car that got shot up last week on Sycamore, the case was drug related. Someone was shooting on Main Street but did not hit anyone.

Auditor's Report: Auditor Sherry Kirkpatrick was present with no report.

Income Tax Administrator Report: March reports were emailed to council on March 29th.

<u>Property Code Investigator's Report:</u> Jeff Corder was present his report was emailed to council on April 5th.

23-19 an ordinance to amend ordinance 18-19 amending the Zoning Map of the City of Coshocton for 200 South Second Street. After the first reading Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 23-19 passed.

24-19 an ordinance to amend Chapter 939 Section 939.11 of the City of Coshocton's Codified Ordinances Charges for Septic Sewage Hauler Discharge. After the first reading Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Mike Gross, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 24-19 passed.

20-19 an ordinance to amend ordinance 57-18 establishing wages for those positions that are exempt from collective bargaining and adding Water Treatment Plant Superintendent and Wastewater Treatment Plant Superintendent. Ordinance to take its course.

17-19 an ordinance approving the edition and inclusion of certain ordinances as part of the various component codes of the Codified Ordinances of the City of Coshocton by the Walter Drane Company. After the third reading all members voted yes. Ordinance 17-19 passed.
