

**Record of Proceedings
Coshocton City Council
Meeting Held: May 29, 2018**

6:45 Public Hearing for Hall Park Renovations was called to order at 6:45 by President Pro Tem Jackie Salmans. Coshocton City Recreation Director, Steve Jones made a presentation to Council and answered several questions. The meeting closed at 7:00 pm.

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Pro Tem Jackie Salmans. Council Members present were President Pro Tem Jackie Salmans, Mr. Mike Gross, Mr. Chad Johnson, Mr. Brad Fuller, Mr. Roger Moore, Mr. Tom Grier, Mr. Glenn Mishler and Cherry Wilson, Clerk. Also, present Mr. Steve Mercer, Mayor and Mr. Max Crown, Safety Service Director. Tom Grier made a motion to excuse President Cliff Biggers, seconded by Roger Moore all members voted yes. President Biggers was excused.

Previous Meeting Minutes: President Pro Tem Salmans confirmed that all council members had received the minutes from 5/14/18. Tom Grier made the motion to accept the minutes as presented, seconded by Chad Johnson. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Stan Braxton spoke to council regarding the vacant property ordinance. Mr. Braxton was against the ordinance. He stated he has 40 rentals in the city, his taxes are paid, his mortgages are paid, he should be able to choose to either fill the properties he owns or leave them vacant. Brad Fuller, Chair of the Ordinance Committee addressed some of Mr. Braxton's concerns.

Jill Baumgardner addressed council regarding the injections wells. She urged council to make a proclamation or statement against the well type being changed at Buckeye Brine. "As leaders of the community people look to you for leadership, when you don't voice your concern, citizens seem to think it is not a big deal if our leadership is not objecting to it."

Reports of Standing or Special Committees: None.

City Officers Reports:

Mayor's Report: Mayor Mercer went over his monthly report that was included in council packets.

Service Director's Report: Max Crown announced the clock at Hickory and Main Street will be installed tomorrow. The Chestnut Street sewer line camera project is 50% completed. The North End Revitalization homes to be demolished will have asbestos inspections done tomorrow.

Sheriff's Office Report: Officer Tyler Mann was present with no report.

Law Director's Report: Bob Skelton was present; his monthly reports were included in council packets.

Auditors Report: Auditor Sherry Kirkpatrick was present and asked council to approve the Detailed Check Report dated 5/7/18 & 5/16/18 and Then and Now's dated 5/16/18. Brad Fuller made a motion to accept the reports as presented, seconded by Roger Moore all members voted yes.

Introduction of Ordinances:

Additions: Roger Moore made a motion to add Ordinance 46-18 to the Agenda, seconded by Chad Johnson, all members voted yes.

Legislation at first reading:

43-18 an ordinance to amend Chapter 905 Section 905.12 of the City of Coshocton's Codified Ordinances. Ordinance to take its course.

44-18 transfers. After the first reading Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Brad Fuller made a motion to suspend the rules and give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 44-18 passed with emergency clause.

45-18 appropriations. After the first reading Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 45-18 passed with emergency clause.

46-18 an ordinance authorizing the Mayor or Service Director to sign all documents necessary for the city to enter into a Water Line Extension agreement with the Meadows of Light Church. After the first reading Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Glenn Mishler, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Brad Fuller, all members voted yes. After the third reading all members voted yes. Ordinance 46-18 passed.

Legislation at second reading:

30-18 appropriations. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Tom Grier, all members voted yes. After the third reading all members voted yes. Ordinance 30-18 passed with emergency clause.

31-18 an ordinance to amend the City of Coshocton Building Code adding Chapter 1355, Sections 1355.01 through 1355.09 Vacant Residential and Commercial Properties. Ordinance to take its course.

Legislation at third reading:

28-18 an ordinance vacating a 15 Foot alley totaling 0.1178 Acres from Elm Street to the end that was previously vacated by ordinance 71-46. All members voted yes. Ordinance 28-18 passed.


