

**Record of Proceedings
Coshocton City Council
Meeting Held: June 10, 2019**

President Biggers called the Public Budget Hearing to order at 6:45 pm. There were no questions or concerns voiced at this hearing. Hearing was closed at 7:00 pm.

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers. Council Members present Mr. Brad Fuller, Mr. Mike Gross, Mr. Chad Johnson, Mr. Glenn Mishler, Mr. Roger Moore, Ms. Jackie Salmans and Cherry Wilson, Clerk. Glenn Mishler made a motion to excuse Mr. Tom Grier, seconded by Chad Johnson, all members voted yes, Mr. Grier was excused. Also, present Mr. Steve Mercer, Mayor and Mr. Max Crown, Safety Service Director.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 5/28/19. Jackie Salmans made the motion to accept the minutes as presented, seconded by Chad Johnson. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Chris Wilson with Washington County Building Department introduced himself to council and explained what Washington County Building Department can offer the city. Council was interested in Mr. Wilson giving a presentation at a later date.

Steve Johnson addressed council regarding concerns at 741 SR 541, his wife's parents' home. There has been a water leak on their property for over 3 years. The leak comes from a broken water line in a right of way beside their property. It has damage to their home and their property. He had several pictures he passed around to council for them to review. He asked that water service be suspended on that water line serving 5 homes be turned off immediately until the water line has been repaired.

Richard Gates of South Lawn Avenue again told council the Sheriff's Office is not responding to his concerns fast enough regarding speeding and loud music in his neighborhood.

Introduction of Ordinances:

Chad Johnson made a motion to add Ordinance 34-19 to the Agenda, seconded by Mike Gross, all members voted yes.

LEGISLATION AT FIRST READING

33-19 an ordinance adopting the budget of the City of Coshocton, Ohio, for the fiscal year beginning January 2020, and submitting same to the County Auditor. Ordinance to take its course.

34-19 appropriations. After the first reading Jackie Salmans made a motion to suspend the rules and give the ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 34-19 passed with the emergency clause.

28-19 an ordinance limiting the jurisdiction of the Civil Service Commission of the City of Coshocton by excluding from its coverage the Coshocton City School District. Ordinance to take its course.
