

**Record of Proceedings
Coshocton City Council
Meeting Held: June 11, 2018**

The Budget Hearing was called to order by President Cliff Biggers at 6:45. There were no questions, comments or concerns. President Biggers closed the hearing at 7:00 pm.

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers. Council Members present were President Cliff Biggers, Mr. Mike Gross, Mr. Chad Johnson, Ms. Jackie Salmans, Mr. Brad Fuller, Mr. Roger Moore, Mr. Glenn Mishler and Cherry Wilson, Clerk. Also, present Mr. Steve Mercer, Mayor and Mr. Max Crown, Safety Service Director. Chad Johnson made a motion to excuse Mr. Tom Grier, seconded by Roger Moore, all members voted yes to excuse Mr. Grier.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 5/29/18. Jackie Salmans made the motion to accept the minutes as presented, seconded by Roger Moore. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Carol and Larry Bobbitt of Swayne Street addressed council about getting their street repaired. They would like to see the schedule of streets being paved this year. They would be happy with patching this year if it would be paved in 2019 when Hydraulic Av gets paved. Service Director Crown told them it was going to be paved with the paving box this year. The County Engineer will assist in training the City Street Department how to use the paving box, Swayne and South 14th Street were chosen to do this year.

Council also asked Max for a paving schedule.

Mike Boals a county resident addressed council with his concerns regarding the Vacant Property Ordinance.

Marvin Lillibridge of West Street shared his concerns regarding the Vacant Property Ordinance and the Littering in the Streets Ordinance that addresses mowing into public streets.

Councilman Brad Fuller tried to explain to both guest the spirit the ordinance was written in was to make sure the city doesn't have empty buildings just sitting around and especially on Main Street.

Reports of Standing or Special Committees: None.

City Officers Reports:

Mayor's Report: Mayor Mercer went over his monthly report that was included in council packets.

Service Director's Report: Max Crown explained the FEMA Grant the city is applying for is to fix a drainage problem in Roscoe Village by Keifer's Florist. He asked for prayers and thoughts for Dave McVay, Utilities Director he is in Akron General Hospital.

Law Director's Report: Bob Skelton was present with no report.

Auditors Report: Auditor Sherry Kirkpatrick was present and asked council to approve the Detailed Check Report dated 5/30, Then and Now's dated 5/30/18 and Statement of Cash dated 5/31/18. Jackie Salmans made a motion to accept the reports as presented, seconded by Glenn Mishler all members voted yes.

Public Works Director's Report: Director Kevin Sharier was present with no report.

Property Code Investigator's Report: Jeff Corder was present with no report.

Port Authority Director's Report: Tiffany Swigert was present with no report.

Introduction of Ordinances:

Additions: Glenn Mishler made a motion to add Ordinance 48-18 to the Agenda, seconded by Jackie Salmans, all members voted yes.

Legislation at first reading:

47-18 an ordinance authorizing the mayor or service director to sign all documents necessary to apply for the Public Assistance Grant Program for FEMA DR-4360- OH. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Glenn Mishler made a motion to suspend the rules and give the ordinance a third reading, seconded by Mike Gross, all members voted yes. After the third reading all members voted yes. Ordinance 47-18 passed with emergency clause.

48-18 an ordinance adopting the budget of the City of Coshocton, Ohio, for the fiscal year beginning January 2019, and submitting same to the county auditor. Ordinance to take its course.

Legislation at second reading:

43-18 an ordinance to amend Chapter 905 Section 905.12 of the City of Coshocton's Codified Ordinances. Ordinance to take its course.

Legislation at third reading:

31-18 an ordinance to amend the City of Coshocton Building Code adding Chapter 1355, Sections 1355.01 through 1355.09 Vacant Residential and Commercial Properties. Ordinance to take its course.




