

**Record of Proceedings
Coshocton City Council
Meeting Held: June 26, 2017**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers, Council Members present were Mr. Bob Feters, Mr. Roger Moore, Mr. Tom Grier and Mr. Glenn Mishler. Glenn Mishler made a motion to excuse Brad Fuller and Jackie Salmans, seconded by Roger Moore, all members voted yes. Also present Mr. Steve Mercer, Mayor; Mr. Max Crown, Safety Service Director and Ms. Cherry Wilson, Clerk.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 6/12/17. Tom Grier made the motion to accept the minutes as presented seconded by Glenn Mishler. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Mike Jansen with Coshocton Christian School asked cancel to rescind the resolution regarding allowing Medical Marijuana manufacturing to locate in Coshocton. Tim Everhart and Chris Cutshall both asked council to rescind the resolution as well.

Reports of Standing or Special Committees: None

City Officers Report:

Mayor's Report: Mayor Mercer announced there was a significant event last week at South Lawn Cemetery. A soldier, Private Eugene Appleby was found in the Netherlands and was brought home and buried beside some of his family in South Lawn Cemetery. The soldiers surviving family was overwhelmed by the community response.

Service Director's Report: Max Crown reported he attended the funeral and graveside services of Private Appleby who was reported missing during WWII. He said his family said they felt peace when they passed through the gates of the cemetery. Mr. Crown also reported he had attended the kick off meeting this morning along with the Mayor for the America in Bloom judges that are in Coshocton this week.

Law Director's Report: Bob Skelton was present and his June report was included in council packets.

Sheriff's Office Report: Officer Hardaway and one other officer were present with no report.

Fire Chief's Report: Chief Layton was present with no report.

Auditors Report: Auditor Sherry Kirkpatrick asked that the Detailed Check Report dated 6/14/17 be approved tonight. Glenn Mishler made a motion to approve the Auditor's report, seconded by Bob Feters, all members voted yes.

Introduction of Ordinances:

Legislation at first reading:

27-17 appropriations. Ordinance to take its course.

Legislation at second reading:

21-17 an ordinance adopting the budget of the City of Coshocton, Ohio, for the fiscal year beginning January 2018, and submitting same to the County Auditor. Ordinance to take its course.

22-17 an ordinance authorizing the Mayor or Service Director to sign the lease agreement between the City of Coshocton and the Ohio Department of Natural Resources (ODNR). Ordinance to take its course.

23-17 an ordinance authorizing the Mayor or Service Director to sign the easement agreement between the City of Coshocton and AEP Ohio. Ordinance to take its course.

24-17 an ordinance giving consent to the Director of Transportation to complete replacing bridges on SR 541 within the City of Coshocton. Ordinance to take its course.

Legislation at third reading:

17-17 an ordinance to amend 1502 Chestnut Street on the Zoning Map of the City of Coshocton. After the third reading all members voted yes. Ordinance 17-17 passed.

19-17 Appropriations. After the third reading all members voted yes. Ordinance 19-17 passed.


