

**Record of Proceedings
Coshocton City Council
Meeting Held: July 1, 2019**

Meeting was rescheduled from June 24th due to the weather.

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers. Council Members present Mr. Brad Fuller, Mr. Tom Grier, Mr. Mike Gross, Mr. Chad Johnson, Mr. Glenn Mishler, Mr. Roger Moore and Cherry Wilson, Clerk. Chad Johnson made a motion to excuse Ms. Jackie Salmans, seconded by Roger Moore, all members voted yes, Ms. Salmans was excused. Also, present Mr. Steve Mercer, Mayor and Mr. Max Crown, Safety Service Director.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 6/10/19. Chad Johnson made the motion to accept the minutes as presented, seconded by Tom Grier. After a roll call vote all members voted yes.

Reports of Standing or Special Committees: Glenn Mishler announced the amendment of the Council Rules were on the agenda tonight.

City Officers Reports:

Mayor's Report: Mayor Mercer invited everyone to the 4th of July Fireworks at the Coshocton County Fairgrounds, on Wednesday.

Service Director's Report: Max Crown thanked Tom Barcroft with Our Town Coshocton for them hosting the Cassee Allen concert. "It was better than last year this is and an event the city could build on".

Max also thanked the City Fire Department for the great job they did on the old Ansell Edmont building fire. They were on site 8 minutes after the 911 call was received. Did a great job containing the fire. He also thanked the additional help and support received.

Law Director's Report: Bob Skelton was present his May Report was emailed to council on 6/19/19.

Auditor's Report: Auditor Sherry Kirkpatrick was present and requested council to approve the following reports. Then and Now's dated 6/27/19; Detailed Check Reports dated 6/12/19, 6/14/19 & 6/27/19 and the Cash Statement dated 6/28/19. Chad Johnson made a motion to accept the reports as presented, seconded by Roger Moore, all members voted yes. The reports were accepted as presented.

Property Code Investigator's Report: Jeff Corder was present with no report.

Income Tax Office Report: The June Report was emailed to council on 6/28/19.

Coshocton Port Authority Report: The June Report was emailed to council on 6/11/19.

Introduction of Ordinances:

Tom Grier made a motion to add Ordinance 36-19 to the Agenda, seconded by Glenn Mishler, all members voted yes.

President Biggers asked council if there were any objections to the amended council rules, there were no objections the new rules were accepted.

LEGISLATION AT FIRST READING

35-19 an ordinance authorizing the mayor or service director to sign all documents necessary for the city to purchase property at Fairy Falls Drive from Otsego Avenue to the railroad tracks in the City of Coshocton. Ordinance to take its course.

36-19 transfers. After the first reading Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Tom Grier, all members voted yes. After the third reading all members voted yes. Ordinance 36-19 passed with the emergency clause.

LEGISLATION AT SECOND READING

33-19 an ordinance adopting the budget of the City of Coshocton, Ohio, for the fiscal year beginning January 2020, and submitting same to the County Auditor. Ordinance to take its course.

LEGISLATION AT THIRD READING

28-19 an ordinance limiting the jurisdiction of the Civil Service Commission of the City of Coshocton by excluding from its coverage the Coshocton City School District. Brad Fuller made a motion to table the ordinance until he can get more information, seconded by Roger Moore. Five members voted yes with Mike Gross voting no. Ordinance 28-19 was tabled.


