# Record of Proceedings Coshocton City Council Meeting Held: July 8, 2019

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers. Council Members present Mr. Brad Fuller, Mr. Mike Gross, Mr. Chad Johnson, Mr. Glenn Mishler, Mr. Roger Moore, Ms. Jackie Salmans and Cherry Wilson, Clerk. Chad Johnson made a motion to excuse Mr. Tom Grier, seconded by Glenn Mishler, all members voted yes, Mr. Grier was excused. Also, present Mr. Steve Mercer, Mayor and Mr. Max Crown, Safety Service Director. The meeting was held at the Art Park on Main Street.

**Previous Meeting Minutes:** President Biggers confirmed that all council members had received the minutes from 7/1/19. Roger Moore made the motion to accept the minutes as presented, seconded by Chad Johnson. After a roll call vote all members voted yes.

**Petitions & Remonstrance's**: Anne Cornell with the Pomerene Arts Center invited everyone to attend a Night at the Movies in the artPark, Saturday night.

### **City Officers Reports:**

<u>Mayor's Report:</u> Mayor Mercer went over his June Monthly Report that was emailed to council on 7/8/19.

<u>Service Director's Report:</u> Max Crown reported the Bridge Project is running ahead of schedule and project pouring mid-August.

The city has used over 200 tons of black top in potholes so far this year.

Hall Park Project will begin next week.

Law Director's Report: Bob Skelton was present, no report.

Auditor's Report: Auditor Sherry Kirkpatrick was present with no report.

#### **Introduction of Ordinances:**

### LEGISLATION AT FIRST READING

34-19 appropriations. After the first reading Jackie Salmans made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 34-19 passed with the emergency clause.

### **LEGISLATION AT SECOND READING**

35-19 an ordinance authorizing the mayor or service director to sign all documents necessary for the city to purchase property at Fairy Falls Drive from Otsego Avenue to the railroad tracks in the City of Coshocton. Ordinance to take its course.

## **LEGISLATION AT THIRD READING**

33-19 an ordinance adopting the budget of the City of Coshocton, Ohio, for the fiscal year beginning January 2020, and submitting same to the County Auditor. After the third reading all members voted yes. Ordinance 33-19 passed.

28-19 an ordinance limiting the jurisdiction of the Civil Service Commission of the City of Coshocton by excluding from its coverage the Coshocton City School District. After the third reading Fuller and Mishler voted yes, Gross, Johnson, Moore and Salmans voted no. Ordinance 28-19 failed.
