

**Record of Proceedings
Coshocton City Council
Meeting Held: July 9, 2018**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers. Council Members present were President Cliff Biggers, Mr. Mike Gross, Mr. Chad Johnson, Mr. Brad Fuller, Mr. Roger Moore, Mr. Tom Grier, Mr. Glenn Mishler and Cherry Wilson, Clerk. Also, present Mr. Steve Mercer, Mayor and Mr. Max Crown, Safety Service Director. Tom Grier made a motion to excuse Ms. Jackie Salmans seconded by Glenn Mishler, all members voted yes to excuse Ms. Salmans.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 6/25/18. Roger Moore made the motion to accept the minutes as presented, seconded by Chad Johnson. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Beth and Steve Tumblin of 505 Swayne Street made an appeal to council to have their neighbor mow his field. Some council members, the mayor and service director agreed to visit the address in question after tonight's meeting.

Larry Bobbitt of 681 Swayne Street asked for a date that Swayne Street would be paved. Max Crown said it will probably be around the end of August.

Todd Shroyer with Coshocton County EMS just checking in with council to see if they had any questions or concerns. Trying to establish a more frequent dialogue with council.

Chris Lorenz of Sleepy Hollow Drive asked council to revisit allowing Golf Carts to be driven on city streets. She clarified she was asking for neighborhood transportation not on main streets.

Reports of Standing or Special Committees: None.

City Officers Reports:

Service Director's Report: The mayor went over his monthly reports that were included in council packets. He also gave a report on the Riverfront Park and the Waterworks Park.

Service Director's Report: Max Crown reported the North Whitewoman Street project will be completed before July 19th. Friday the pipe for the CR 10 Project will be delivered and the project will commence on the 16th.

Law Director's Report: Bob Skelton was present with no report.

Auditors Report: Auditor Sherry Kirkpatrick was present and asked council to approve the Detailed Check Report dated 6/20/18 & 6/27/18 and the Cash Statement dated 6/29/18. Chad Johnson made a motion to accept the reports as presented, seconded by Brad Fuller all members voted yes.

Property Code Investigator's Report: Jeff Corder was present his report was submitted to the service director today and will be forwarded to council tomorrow.

Income Tax Report: June Report was included in council packets.

Introduction of Ordinances:

Additions: Glenn Mishler made a motion to add Ordinance 23-18 to the Agenda, seconded by Roger Moore, all members voted yes.

Legislation at first reading:

22-18 appropriations. After the first reading Chad Johnson made a motion to suspend the rules and give ordinance a second reading, seconded by Roger Moore, all members voted yes. After

the second reading Brad Fuller made a motion to suspend the rules and give ordinance a third reading, seconded by Glenn Mishler, all members voted yes. After the third reading all members voted yes. Ordinance 22-18 passed with emergency clause.

23-18 an ordinance authorizing the mayor or service director to sign all documents necessary for the city to purchase property at 1100 Walnut Street in the City of Coshocton. Ordinance to take its course.

Legislation at second reading:

21-18 appropriations. After the second reading Brad Fuller made a motion to suspend the rules and give ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 21-18 passed with emergency clause.

Legislation at third reading:

48-18 an ordinance adopting the budget of the City of Coshocton, Ohio, for the fiscal year beginning January 2019, and submitting same to the county auditor. After the third reading Ordinance 48-18 passed.

Resolutions:

4-18 a resolution accepting the update of the District Solid Waste Management Plan. All members voted yes. Resolution 4-18 was adopted.


