

**Record of Proceedings
Coshocton City Council
Meeting Held: September 10, 2018**

At 6:45 pm council held a public hearing for Ordinance 25-18 rezoning for MFM Products Inc. There were no questions or concerns asked and the public hearing closed at 7:00 pm.

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Pro Tem Jackie Salmans. Council Members present were President Pro Tem Jackie Salmans, Mr. Mike Gross, Mr. Chad Johnson, Mr. Brad Fuller, Mr. Roger Moore, Mr. Tom Grier, Mr. Glenn Mishler and Cherry Wilson, Clerk. Also, present Mr. Steve Mercer, Mayor and Mr. Max Crown, Safety Service Director. Glenn Mishler made a motion to excuse President Cliff Biggers, seconded by Chad Johnson, all members voted yes to excuse Mr. Biggers.

Previous Meeting Minutes: President Pro Tem Salmans confirmed that all council members had received the minutes from 7/23/18 and Special Meeting 7/30/18. Tom Grier made the motion to accept the minutes as presented, seconded by Mike Gross. After a roll call vote all members voted yes.

Petitions & Remonstrance's: Karen Casey of Adams Street addressed council regarding the homeless population. Ms. Casey pled with council to find a solution to care for the homeless. She asked the city of fund or find someone to fund a homeless shelter she said she had over 70 volunteers that would work a shelter. "We have to allocate a place for them to be."

Monty Shale with Buckeye Brine was present, he informed everyone the Ohio EPA has issued two draft permits to convert two of their three class II wells into class I nonhazardous injection waste wells. The EPA will have a public hearing at 6:00 PM on Thursday October 18th at Coshocton high school.

Tyler Shipley a candidate for State Representative introduces himself to council and the audience. He spoke briefly about the state funding that has been reduced.

Reports of Standing or Special Committees: None.

City Officers Reports:

Mayor's Report: The Mayor went over his July and August Reports that were included in council packets. The AFSCME agreement was voted down by the union and we are waiting to hear from them again. A river walk planning meeting is scheduled for Monday the 24.

Service Director's Report: Max Crown reported the PA system was installed Saturday. The public works department is approximately two weeks behind on paving due to the weather. The tree commission planted trees on south seventh street, with 4 to 5 left and over that were planted at Bancroft park. The city received approximately 5 inches of rain over the weekend, the rain came slowly and the city fared well.

Law Director's Report: Bob Skelton was present; his July monthly report was in council packets.

Auditors Report: Auditor Sherry Kirkpatrick was present and asked council to approve the Detailed Check Report dated 7/11/18, 7/25/18, 8/8/18, 8/13/18 & 8/23/18, Cash Statement dated 7/31/18 & 8/31/18 and Then & Now's dated 7/25/18, 8/8/18 & 8/23/18. Roger Moore made a motion to accept the reports as presented, seconded by Glenn Mishler all members voted yes.

Property Code Investigator's Report: Jeff Corder was present his July & August reports were included in council packets.

Public Works Report: Kevin Sharier was present with no report.

Coshocton Port Authority Report: Tiffany Swigert was present with no report.

Introduction of Ordinances:

25-18 an ordinance to amend the zoning map of the City of Coshocton for the following addresses on South 6th Street in the City of Coshocton 315, 317, 319, 321, 325, 327 & 329 and a portion of vacated alley. Ordinance to take its course.

26-18 transfers. After the first reading Tom Grier made a motion to suspend the rules and give ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Glenn Mishler made a motion to suspend the rules and give ordinance a third reading, seconded by Brad Fuller, all members voted yes. After the third reading all members voted yes. Ordinance 26-18 passed with emergency clause.

27-18 appropriations. After the first reading Tom Grier made a motion to suspend the rules and give ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give ordinance a third reading, seconded by Glenn Mishler, all members voted yes. After the third reading all members voted yes. Ordinance 27-18 passed with emergency clause.

34-18 an ordinance approving the addition and inclusion of certain ordinances as part of the various component codes of the Codified Ordinances of the City of Coshocton by the Walter Drane Company. Ordinance to take its course.

35-18 an ordinance regarding vagrants in the City of Coshocton. Ordinance to take its course.

36-18 an ordinance not allowing camping on any property owned by the City of Coshocton. Ordinance to take its course.
