

**Record of Proceedings
Coshocton City Council
Meeting Held: September 25, 2017**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers, Council Members present were Mr. Bob Fethers, Mr. Brad Fuller, Ms. Jackie Salmans, Mr. Roger Moore, Mr. Tom Grier and Mr. Glenn Mishler. Also present Mr. Steve Mercer, Mayor; Mr. Max Crown, Safety Service Director and Ms. Cherry Wilson, Clerk. *Chad Johnson present CW*

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 9/11/17. Tom Grier made the motion to accept the minutes as presented seconded by Roger Moore. After a roll call vote all members voted yes.

City Officers Report:

Mayor's Report: Mayor Mercer no report.

Service Director's Report: Max Crown reported the Public Works Department has changed the flow of traffic for the fair as usual and are looking at secondary streets to pave.

Law Director's Report: Bob Skelton was present; his August Report was included in council packets.

Auditors Report: Auditor Sherry Kirkpatrick was present and asked council to approve the Detailed Check Report dated 9/7/17. Brad Fuller made a motion to accept the reports, seconded by Glenn Mishler all members voted yes.

Port Authority Report: The Coshocton Port Authority's September Report was included in council packets.

Introduction of Ordinances:

Jackie Salmans made a motion to add Ordinance 32-17, seconded by Tom Grier, all members voted yes. Ordinance 32-17 was added to the agenda.

Legislation at first

31-17 Appropriations. After the first reading, Jackie Salmans made a motion to suspend the rules and give the ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Tom Grier made a motion to give the ordinance a third reading, seconded by Chad Johnson, all members voted yes. After the third reading all members voted yes. Ordinance 31-17 passed with the emergency clause.

32-17 An ordinance authorizing the Mayor or Service Director to enter into an agreement to extend the lease with the Coshocton Alternative School for the leasing of the former Armory Building Gymnasium. After the first reading, Tom Grier made a motion to suspend the rules and give the ordinance a second reading, seconded by Bob Fethers, all members voted yes. After the second reading Brad Fuller made a motion to give the ordinance a third reading, seconded by Jackie Salmans, all members voted yes. After the third reading all members voted yes. Ordinance 32-17 passed with the emergency clause.

Legislation at second reading:

28-17 an ordinance to amend zoning ordinances in the City of Coshocton's Codified Ordinances. Ordinance to take its course.

Legislation at third reading:

None

Resolutions: 11-17 a resolution ordering the insecure, dangerous or hazardous structure(s) on the property at 304 North 14th Street in the City of Coshocton be removed or abated. Roll call vote all members voted yes. Resolution 11-17 was adopted.


Unfinished Business: None
