After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Glenn Mishler, all members voted yes. After the second reading Roger Moore made a motion to suspend the rules and give the ordinance a third reading, seconded by Glenn Mishler, all members voted yes. After the third reading all members voted yes, ordinance 53-19 passed with the emergency clause.

54-19 an ordinance authorizing the mayor or service director to sign all documents necessary to renew the Joint Economic Development District between the City of Coshocton and Franklin Township located in the County of Coshocton. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Mike Gross, all members voted yes. After the third reading all members voted yes, ordinance 54-19 passed with the emergency clause.

55-19 an ordinance authorizing the mayor, service director and/or city auditor to borrow the funds necessary for the purchase of a new fire truck. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading ordinance will takes its course.

56-19 an ordinance authorizing the mayor and/or service director to enter into a contract to purchase a new one hundred (100) foot Aerial Pierce Arrow fire truck for the price of \$1,365,535.00. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Mike Gross, all members voted yes. After the second reading ordinance will takes its course.

57-19 an ordinance authorizing the mayor or service director to prepare specifications and advertise for bid of refuse and recycle services for the City of Coshocton. Ordinance to take its course.
