**ANY PROJECT THAT REQUIRES A BUILDING PERMIT BUT DOES NOT OBTAIN ONE SHALL BE ISSUED A STOP WORK ORDER CCCO 1305.09**

**ANY CONTRACTOR FOUND TO BE WORKING WITHOUT FIRST REGISTERING WITH THE CITY SHALL BE ISSUED A STOP WORK ORDER THAT SHALL REMAIN IN FORCE UNTIL REGISTRATION IS ACCOMPLISHED PER CCCO 736.06**

### Fees to be submitted with application

Residential Projects are \$25.00 for the first \$5,000 of project cost, \$1.00 per thousand thereafter

Commercial Projects are \$100.00 for the first \$10,000 of project cost, \$2.00 per thousand thereafter
