

**Record of Proceedings
Coshocton City Council
Meeting Held: September 28, 2020 Via ZOOM**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Cliff Biggers. Council Members present, Ms. Kayley Andrews, Mr. Chad Johnson, Mr. Glenn Mishler, Mr. Roger Moore, Ms. Jackie Salmans, Ms. Michelle Turner and Ms. Cherry Wilson, Clerk. Chad Johnson made a motion to excuse Mr. Mike Gross, seconded by Glenn Mishler, all members voted yes. Also, present Mr. Mark Mills, Mayor and Mr. Max Crown, Safety Service Director.

During the COVID 19 Pandemic city council meetings are being held by video conferencing via ZOOM and being broadcast live on YouTube on the Coshocton City Hall Channel.

Previous Meeting Minutes: President Biggers confirmed that all council members had received the minutes from 9/14/20. Chad Johnson made a motion to accept the minutes as presented, seconded by Roger Moore. After a roll call vote all members voted yes, minutes were accepted as presented.

City Officers Reports:

Mayor's Report: The Mayor reported he has been in meetings with the Sheriff's Office regarding targeting areas that people are driving over the speed limit in. He announced Trick or Treat will be October 31st from 5:00 pm to 6:30 pm in the city. Wi-Fi access and cameras will be installed at Bancroft Park & Himebaugh Park soon. The Mayor asked park users to respect the facilities and clean up any messes you make while visiting our community parks.

Service Director's Report: Max Crown was present and reminded everyone Chestnut Street from 4th to 6th Streets will be closed for railroad track repairs, detours will be posted.

Law Director's Report: Bob Skelton was present, and his August report was emailed to council on 9/16/20.

Auditor's Report: Sherry Kirkpatrick was present and asked council to approve a correction on the Detailed Check Report dated 8/20/20 (approved at the 9/14/20 meeting) there were 2 checks on that report dated 8/25/20. Glenn Mishler made a motion to accept this correction, seconded by Kayley Andrews, all members voted yes.

Property Code Investigator: Jeff Corder was present with no report. Glenn Mishler noted there are several cars being parked on curbs and in front yards. Jeff will investigate.

Sheriff's Office Report: Sheriff Rogers was present with no report. He will start sending his reports to council via email.


