After the second reading Kayley Andrews made a motion to suspend the rules and give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 62-20 passed with emergency clause.

Chad Johnson made a motion to amend Ordinance 63-20 the dollar amount in Section 1 to 196,785.85 and add Section 2, seconded by Kayley Andrews, all members voted yes.

63-20 appropriations. Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Kayley Andrews made a motion to suspend the rules and give the ordinance a third reading, seconded by Michelle Turner, all members voted yes. After the third reading all members voted yes. Ordinance 63-20 passed with emergency clause.
