

**Record of Proceedings
Coshocton City Council
Meeting Held: May 24, 2021**

6:45 Public Hearing for DORA. No communication was received. Meeting closed at 7:00 pm.

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Tom Hilgenberg. Council Members present, Mr. Mike Gross, Mr. Chad Johnson, Mr. Glenn Mishler, Mr. Roger Moore, Mr. Tom Barcroft, Ms. Michelle Turner and Ms. Cherry Wilson, Clerk. Glenn Mishler made a motion to excuse Kayley Andrews, seconded by Michelle Turner, all members voted yes. Kayley Andrews was excused. Also, present Mr. Mark Mills, Mayor and Max Crown, Service Director.

Council Meetings are now broadcast live on YouTube on the Coshocton City Hall Channel.

Previous Meeting Minutes: President Hilgenberg confirmed that all council members had received the minutes from 5/10/21. Roger Moore made a motion to accept the minutes as presented, seconded by Tom Barcroft. After a roll call all members voted yes, with Michelle Turner abstaining, minutes were accepted as presented.

Petitions & Remonstrance's: The public was provided an email address questions@cityofcoshocton.com to submit questions, concerns and comments during the meeting. Richard Gates of South Lawn Avenue addressed council with concerns about Taxi's flying up and down South Lawn Avenue and blowing through stop signs. He also said people are walking dogs with no leashes and not cleaning up after them.

Reports of Standing or Special Committees: None

City Officers Reports:

Mayor's Report: Mayor Mills congratulated all area High School Seniors. The Art Mob Project will begin soon. He also said he is excited about the DORA Committee working out the details for the future DORA.

Service Director's Report: Max thanked Out Town Coshocton for cleaning up Main Street and Painting Fire Hydrants.

Law Director's Report: Bob Skelton was present with no report. He addressed Mr. Gates concerns, dogs that are under reasonable control of the owner are fine with no leash. He advised Mr. Gates to call the Dog Warden or Sheriff's Office for other concerns.

Auditor's Report: Sherry Kirkpatrick was present with no reports.

Sheriff's Report: Sheriff Crawford was present his reports were emailed to council on 5/22/21.

Property Code Investigator: Jeff Corder was present and reported 11 streets are adopted that is approximately 88 blocks that will be kept litter free by volunteers. We know have 86 UTV's licensed. Camera's for Himebaugh Park went live today.

Introduction of Ordinances:

Tom Barcroft made a motion to add Ordinance 19-21, Ordinance 23-21 and Resolution 4-21 to the agenda, seconded by Chad Johnson, all members voted yes.

LEGISLATION AT FIRST READING

19-21 an ordinance to rescind the City of Coshocton Codified Ordinance Chapter 1111 Amendments. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Michelle Turner made a motion to give the ordinance a third reading, seconded by Glenn Mishler, all members voted yes. After the third reading all members voted yes. Ordinance 19-21 passed.

21-21 an ordinance to establish a new fund #114 named "American Rescue Plan Fund". After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Tom Barcroft, all members voted yes. After the second reading Roger Moore made a motion to give the ordinance a third reading, seconded by Mike Gross, all members voted yes. After the third reading all members voted yes. Ordinance 21-21 passed.

22-21 appropriations. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Tom Barcroft, all members voted yes. After the second reading Michelle Turner made a motion to give the ordinance a third reading, seconded by Glenn Mishler, all members voted yes. After the third reading all members voted yes. Ordinance 22-21 passed.

23-21 an ordinance approving the edition and inclusion of certain ordinances as parts of the various component codes of the Codified Ordinances of Coshocton, Ohio, and declaring an emergency. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Roger Moore, all members voted yes. After the second reading Michelle Turner made a motion to give the ordinance a third reading, seconded by Tom Barcroft, all members voted yes. After the third reading all members voted yes. Ordinance 23-21 passed.

LEGISLATION AT SECOND READING

18-21 an ordinance to amend the City of Coshocton Codified Ordinance Chapter 1117 R-1 One-Family Residence District. Ordinance to take its course.

LEGISLATION AT THIRD READING

16-21 an ordinance to amend the City of Coshocton Codified Ordinance 376 Utility Task Vehicles (UTV). After the third reading all members voted yes. Ordinance 16-21 passed.

RESOLUTIONS:

resolution 4-21 a resolution authorizing the formation of a partnership with Coshocton County to act as the official grantee for the PY 2021 Community Housing Impact and Preservation Program (CHIP). All members voted yes. Resolution 4-21 was adopted.

New Business:


