Coshocton City Council
Meeting Held: June 28, 2021**

6:45 Public Hearing for Planning Zoning Commission 2-21 Ordinance 31-21. There was no public input for this hearing.

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Tom Hilgenberg. Council Members present, Mr. Mike Gross, Mr. Chad Johnson, Ms. Kayley Andrews, Mr. Glenn Mishler, Mr. Roger Moore, Mr. Tom Barcroft, Ms. Michelle Turner and Ms. Cherry Wilson, Clerk. Kayley Andrews was excused. Also, present Mr. Mark Mills, Mayor and Max Crown, Service Director.

Previous Meeting Minutes: President Hilgenberg confirmed that all council members had received the minutes from 5/24/21 & 6/14/21. Kayley Andrews made a motion to accept the minutes as presented, seconded by Roger Moore. After a roll call all members voted yes, minutes were accepted as presented.

LEGISLATION AT FIRST READING

27-21 an ordinance to transfer remaining Coshocton City Home Health Agency Funds to the General Fund. Ordinance to take its course.

28-21 transfers. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Glenn Mishler, all members voted yes. After the second reading Roger Moore made a motion to give the ordinance a third reading,

seconded by Michelle Turner, all members voted yes. After the third reading all members voted yes. Ordinance 28-21 passed.

29-21 an ordinance adopting the budget of the City of Coshocton, Ohio for the fiscal year beginning January 2022, and submitting same to the County Auditor. After the first reading Kayley Andrews made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Michelle Turner made a motion to give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 29-21 passed.

30-21 an ordinance authorizing the transfer of property to Coshocton County Land Reutilization Corporation. After the first reading Chad Johnson made a motion to suspend the rules and give the ordinance a second reading, seconded by Tom Barcroft, all members voted yes. After the second reading Michelle Turner made a motion to give the ordinance a third reading, seconded by Roger Moore, all members voted yes. After the third reading all members voted yes. Ordinance 30-21 passed.

31-21 an ordinance to allow a set-back variance at 617 Ridgewood Drive, Coshocton Ohio. After the first reading Kayley Andrews made a motion to suspend the rules and give the ordinance a second reading, seconded by Chad Johnson, all members voted yes. After the second reading Roger Moore made a motion to give the ordinance a third reading, seconded by Glenn Mishler, all members voted yes. After the third reading all members voted yes. Ordinance 31-21 passed.

24-21 an ordinance to establish a new fund #940 "West Lafayette Sewer". After the second reading Kayley Andrews made a motion to suspend the rules and give the ordinance a third reading, seconded by Michelle Turner, all members voted yes. 26-21 appropriations. After the second reading Roger Moore made a motion to suspend the rules and give the ordinance a third reading, seconded by Chad Johnson, all members voted yes. After the third reading all members voted yes. Ordinance 26-21 passed.




Mike Gross said Pooch Blackson had passed away he was a local icon and will be missed by many.
