

**Record of Proceedings  
Coshocton City Council  
Meeting Held: September 13, 2021**

The regular session of the Coshocton City Council was called to order at 7:00 pm by Council President Tom Hilgenberg. Council Members present, Mr. Mike Gross, Mr. Chad Johnson, Ms. Kayley Andrews, Mr. Roger Moore, Mr. Tom Barcroft, Ms. Michelle Turner and Mr. Glenn Mishler. Ms. Cherry Wilson, Clerk was absent, Councilman Moore will perform clerk duties tonight during the council meeting. Also, present Mark Mills, Mayor and Max Crown, Service Director.

**Previous Meeting Minutes:** President Hilgenberg confirmed that all council members had received the minutes from 7/26/21. Kayley Andrews made a motion to accept the minutes as presented, seconded by Chad Johnson. After a roll call all members voted yes, minutes were accepted as presented.

Standard Power is cleaning up the former Rock Tenn property. Wendy's is building on South 2<sup>nd</sup> Street. Jenny's Pennys opened on Main Street. Huck's Tavern opened in Roscoe Village. The Port Authority purchased the Downtown Theater Building. Block Party sponsored by Main Street Station.

After the second reading Chad Johnson made a motion to suspend the rules and give the ordinance a third reading, seconded by Glenn Mishler, all members voted yes. After the third reading all members voted yes. Ordinance 34-21 passed.

35-21 an ordinance to amend the City of Coshocton Codified Ordinances Chapter 1333 Nuisances. Michelle Turner made a motion to amend the ordinance, seconded by Roger Moore, all members voted yes. After the first reading Roger Moore made a motion to amend the ordinance, seconded by Tom Barcroft, all members voted yes. After the second reading Michelle Turner made a motion to suspend the rules and give the ordinance a third reading, seconded by Glenn Mishler, all members voted yes. After the third reading 6 members voted yes with Chad Johnson voting no. Ordinance 35-21 passed





**Communications:**
