

Record of Proceedings
Coshocton City Council
Meeting Held: January 9, 2023

Public Hearing was conducted at 6:45 for the application of a Community Entertainment District application. Ordinance 3-23 in on the agenda for tonight's meeting. No action was taken at this time.

The regular session of the Coshocton City Council was called to order at 7:00pm by Council President Tom Hilgenberg. Roger Moore made a motion to suspend the rules and give the ordinance a second and third reading seconded by Michelle Turner. All members voted yes.

2-23 AN ORDINANCE AUTHORIZING THE CITY OF COSHOCTON SAFETY SERVICE DIRECTOR TO APPLY FOR, ACCEPT, AND ENTER INTO A WATER SUPPLY REVOLVING LOAN (WPCLF) ACCOUNT ON BEHALF OF THE CITY OF COSHOCTON FOR THE PLANNING, DESIGN, AND/OR CONSTRUCTION OF THE WASTEWATER FACILITIES; AND DESIGNATING A DEDICATED REPAYMENT SOURCE FOR THE LOAN. Kayley Andrews made a motion to suspend the rules and give the ordinance a second and third reading seconded by Roger Moore. All members voted yes.

3-23 AN ORDINANCE TO AUTHORIZE THE MAYOR OF THE CITY OF COSHOCTON TO MAKE APPLICATION TO THE STATE OF OHIO IN ACCORDANCE WITH THE OHIO REVISED CODE SECTION 4301.80 TO ESTABLISH A COMMUNITY ENTERTAINMENT DISTRICT WITHIN THE CITY OF COSHOCTON, OHIO KNOWN AS THE COSHOCTON COMMUNITY ENTERTAINMENT DISTRICT. Michelle Turner made a motion to suspend the rules and give the ordinance a second and third reading seconded by Tom Barcroft. All members voted yes.


