Coshocton City Council

Meeting Held: March 25, 2024

The regular session of the Coshocton City Council was called to order at 6:30pm by Council President Tom Hilgenberg. Previous Meeting Minutes: President Hilgenberg confirmed that all council members had received the minutes from the March 11, 2024, meeting. Kayley Andrews made a motion to accept the minutes, seconded by Chad Johnson. After a roll call all members voted yes. Roger Moore abstained due to being absent from the previous meeting.

12-24 AN ORDINANCE AUTHORIZING THE MAYOR/SAFETY – SERVICE DIRECTOR OF THE CITY OF COSHOCTON TO ADVERTISE FOR BIDS, OPEND BIDS, AND RECOMMEND THE LOWEST AND BEST BIDDER TO COUNCIL AND SIGN A CONTRACT FOR THE CHESTNUT WATERLINE REPLACEMENT PROJECT. Kayley Andrews made a motion to suspend the rules and give the ordinance a second and third reading, seconded by Roger Moore. After a roll call all members voted yes.

13-24 AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF COSHOCTON TO APPLY FOR, ACCEPT, AND ENTER INTO A COOPERATIVE AGREEMENT FOR CONSTRUCTION OF THE CHESTNUT WATERLINE PROJECT BETWEEN THE CITY OF COSHOCTON AND THE OHIO WATER DEVELOPMENT AUTHORITY AND DECLARING AN EMERGENCY. Roger Moore made a motion to suspend the rules and give the ordinance a second and third reading, seconded by Chad Johnson. After a roll call all members voted yes.

14-24 AN ORDINANCE AUTHORIZING THE CITY OF COSHOCTON TO APPLY FOR, ACCEPT, AND ENTER INTO A WATER SUPPLY REVOLVING LOAN ACCOUNT (WSRLA) AGREEMENT ON BEHALF OF THE CITY OF COSHOCTON FOR CONSTRUCTION OF THE CHESTNUT WATERLINE PROJECT; AND DESIGNATING A DEDICATED REPAYMENT SOURCE FOR THE LOAN. Michelle Turner made a motion to suspend the rules and give the ordinance a second and third reading, seconded by Tom Barcroft. After a roll call all members voted yes.

8-24 AN ORDINANCE AUTHORIZING THE SERVICE DIRECTOR TO SIGN ALL DOCUMENTS NECESARRY TO TRANSFER PARCEL NUMBER 037-15200026-00, 1.45 ACRES OF PROPERTY TO THE COSHOCTON COUNTY COMMISSIONERS FOR SKIPS LANDING RIVERWALK PROJECT. After a roll call all members voted yes.

9-24 AN ORDINANCE AUTHORIZING THE SERVICE DIRECTOR TO PREPARE SPECIFICATIONS, ADVERTISE FOR BIDS AND SIGN A CONTRACT FOR REPAIR/REPLACEMENT OF THE ROOF OF COSHOCTON CITY HALL, 760 CHESTNUT STREET, COSHOCTON, OH 43812. After a roll call all members voted yes.




