## Coshocton City Council

Meeting Held: April 7, 2025

The Committee Meeting started at 5:45pm

President Hilgenberg called the meeting to order. Items for tonight's council meeting were discussed. President Hilgenberg also inquired if there were going to be any Ordinances for the next meeting.

- 1) Council member Moore said the Ordinance Committee will meet and look over the Bike Ordinance and may need it revised.
- 2) The Law Director said they would be looking at the Nuisance Ordinance and may be revising it as well.

Mayor Mills updated the council on projects.

- 1) Clean up Coshocton day will be April 26, 2025, starting at 8:30am. The first fifty people there will get a free t-shirt. Also added for all citizens of Coshocton to clean up their property.
- 2) Citizens will notice flags in yards, these are utility markers for future work. Please be patient as we are working on these projects.
- 3) The Mayor's office will not tolerate littering or vandalism at the City's Parks. As a reminder, there are cameras in all the park areas.

Service Director Crown updated the council on projects.

- 1) Friends of the Park 10K and 5K run will be on April 19,2025 at 8:00am. Currently there are 220 people who have signed up. Please come out and walk or run to show your support.
- 2) The Bell Store at the corner of Chestnut and 2<sup>nd</sup> Street came down fast.
- 3) The Service Director has had numerous complaints from business owners in reference to parking on Main Street.

Council member Barcroft asked about the traffic lights at Cambridge Road and Walnut Street. Possibly the timing is off. Mayor Mills will look into it.

Utilities Director Kadri

- 1) Chestnut Street is scheduled to be completed by the end of May.
- 2) Warsaw water line is scheduled to start on the first of May.
- 3) Brought council up to date on the Conesville project.
- 4) Buena Vista is scheduled to be bid in June and start early in July.
