Coshocton City Council

Meeting Held: September 15, 2025

The Committee Meeting started at 4:00pm.

President Hilgenberg called the meeting to order. Items for tonight's council meeting were discussed.

President Hilgenberg inquired if there were going to be any Ordinances for the next meeting.

- 1) Rules Committee update
- 2) Transfers and Appropriations
- 3) Sheriff's Contract for 2026/2027
- 4) OPWC application

President Hilgenberg informed council that there would be an addition to the agenda. Ordinance 43-25, AN ORDINANCE APPROVING THE EXPANSION REQUEST INTO THE CITY OF COSHOCTON AND FRANKLIN JOINT ECONOMIC DEVELOPMENT DISTRICT (JEDD). Tiffany Swigert from the Port Authority was in attendance to discuss this ordinance. They have received all signatures from all landowners, and the JEDD will be up and running on September 23, 2025. Discussion followed.

Sheriff Walters was in attendance and went over his August report which was emailed to all council members.

Council inquired about the property on Cambridge Road and Morgan Run Road. Deputy Sharrock has been checking into the situation and will report at the next meeting.

Mayor's Report:

- 2) Fifth Street Glove Factory is almost complete.
- 3) Pickleball court completed at KA.
- 4) Paving at the cemetery and in alleys next week.
- 5) Warsaw water line project moving along.
- 6) Final walk through Chestnut Street. Some questions still to be answered.
- 7) Received many emails about the light on the bridge. Asking the public to be patient. If you are coming to the fair, please consider coming on SR83 and Otsego Ave.
- 8) Roundabout project is going well. Reminder that business access is still open. You can get to the Beer Dock and the Scrap Yard.
- 9) Gas company is still working on their lines.

At 5:54 PM Michelle Turner made a motion to enter into executive session pursuant to Ohio Revised Code 121.22g-8 to consider confidential information directly related to economic development that involves public infrastructure improvements and the extension of utility services that are directly related to an economic development project, second, Chad Jonson, all members voted yes.

At 6:20 PM Roger Moore made a motion to exit Executive Session, second, Jim Kreis, all members voted yes. No action was taken.

Committee meeting adjourned at 6:30 PM.

Previous Meeting Minutes: President Hilgenberg confirmed that all council members had received the committee minutes and council minutes from the September 15, 2025, meeting. Chad Johnson made a motion to accept the minutes, second by Roger Moore. After a roll call all members voted yes.

Craig and Christina Breidenback, 13268 Durham Circle, Pickerington, Ohio. Owners of property at 862 Chestnut Street, Coshocton, Ohio. They had received a letter about the trash platform that they put up on Chestnut Street. There are currently six trash cans there for tenants in their building that they have been renovating. The Mayor explained the platform was placed on top of the water lines and would need to be moved. There is no access for the trash truck to get through the alley way. Discussion followed. Bob Beaumont will look into possibly using a smaller truck to pick up. He will report back to the owners and council.

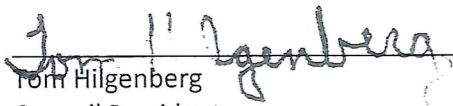
