Coshocton City Council

Meeting Held: September 2, 2025

The Committee Meeting started at 4:00pm.

President Hilgenberg called the meeting to order. Items for tonight's council meeting were discussed.

President Hilgenberg inquired if there were going to be any Ordinances for the next meeting.

President Hilgenberg inquired about unpainted crosswalks needing completed. Mayor will look into it. Also inquired about the trash platform that was situated on Chestnut Street. Mayor is looking into that as well.

Update on Chestnut Street, from Utility Director Kadri, paving should be starting this week.

At 4:18pm Tom Barcroft made a motion to enter into executive session pursuant to Ohio Revised Code 121.22g-8 to consider confidential information directly related to economic development that involves public infrastructure improvements and the extension of utility services that are directly related to an economic development project. Second by Michell Turner, all members voted yes.

At 5:13pm Roger Moore made a motion to exit Executive Session, second by Jim Kreis, all members voted yes.

2. Paving South Lawn Cemetery starts next week.
3. Continuing to cut down dead trees.
4. Will be drag boxing some alleys again.
5. Working on lights on Main Street.

7. Still working on Edmont factory clean up.
8. Lots of things have happened in Coshocton over the past month. Concerts, Car Show, Burn Out, Sunflower Festival.

Council member Moore asked who is responsible for street lighting in Roscoe Village. It is very dark, concerns about someone falling. Discussion followed.

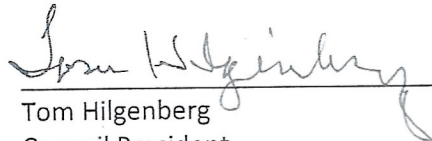

Old Business: None

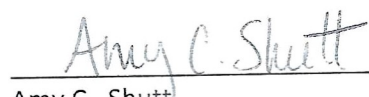
